BY SEP.15

The Government approves the draft budget law and submits it to the Parliament (VRU)



BY OCT.20

The VRU considers the draft and approves Budget Conclusion (1st reading)



BY DEC.01

The draft budget law passes the 2nd reading and is adopted by the VRU
