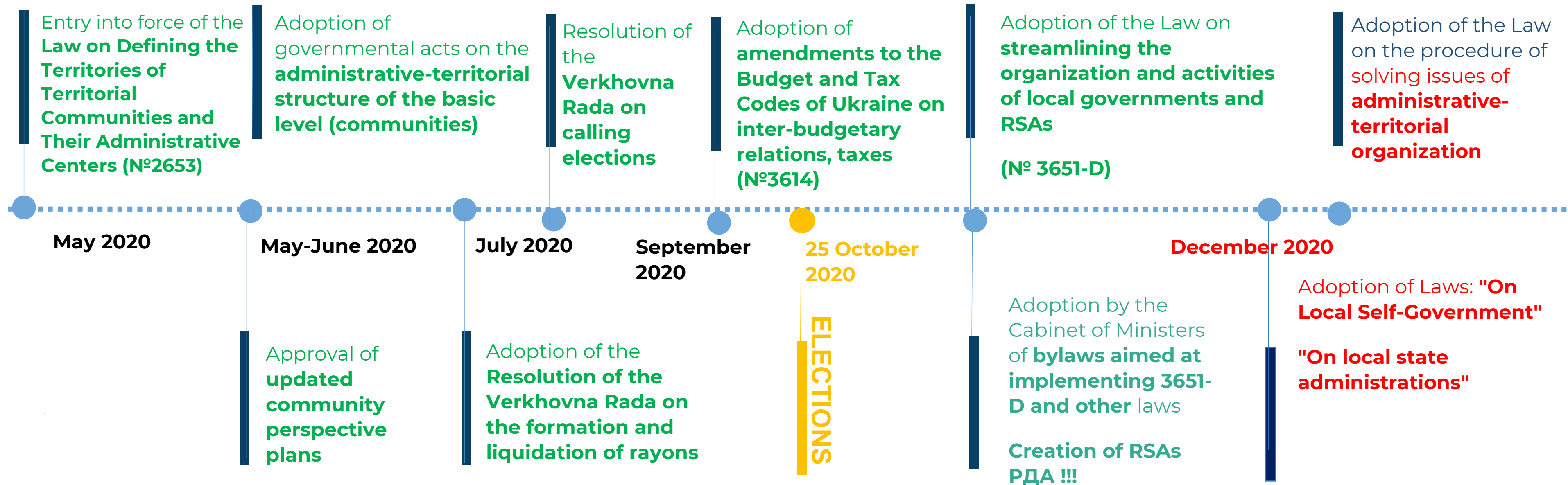

CALENDAR REFORM PLAN FOR 2020

Agreed with the Committee on the Organization of State Power, Local Self-Government, Regional Development and Urban Planning of the Verkhovna Rada of Ukraine





SUPPORT FOR ORGANIZATION OF ACTIVITIES OF TERRITORIAL COMMUNITIES AFTER THE FIRST ELECTIONS

- 1. Delimitation of communal property, other property:**
 - transfer from rayon councils to territorial communities;
 - transfer from old communities to newly formed communities
- 2. Carrying out procedures for the formation of new bodies of legal entities under public law:**
 - Rayon councils;
 - Territorial communities' councils;
 - Reorganization of LSGs – legal entities under public law
- 3. Drafting and adopting local budgets for 2021**
- 4. Establishing the structure of local governments and appointing of staff**
- 5. Organization of TSNAP activities in communities and under the RSA**

LEGAL SUPPORT OF THE REFORM

I. Adopting new versions of the Laws:

1. «On Local Self-governance in Ukraine»
 2. «On Local State Administrations» (N°4298)

3. «On the procedure for resolving issues of administrative-territorial organization of power» (is being reviewed at the CMU)

PRIORITY 8.2. LOCAL SELF-GOVERNANCE, TERRITORIAL ORGANIZATION OF POWER AND ADMINISTRATIVE AND TERRITORIAL SET UP

OBJECTIVE

Establishment and maintenance of a full-fledged living environment, provision of high-quality and accessible public services to residents of territorial communities through the formation of effective local self-government and an optimal system of territorial organization of power.
